Interactive sessions and practical circuit maintenance sessions offered. Feedback will be useful for future courses. Mentorship is an area of interest to Sim Technician. Disappointed that Trust cannot continue funding for a Sim Technician – will explore other avenues of funding. Sim fellow posts have decreased also – in situ work becoming more challenging. | |
| <u>DFT</u> – our funding is limited to 1 year – we hope that when business case is proven through the year, the Trust will then take over leadership of funding. | |
| <u>WT & DT-J</u> – discussion of Sim Technician within ED and time restraints in training for foundation doctors. F1 & F2 programmes are protected. Funding from deanery for F1 skills training – chest drain simulation activity. But the in situ multidisciplinary SIM activity is still insecure. | |
| <u>DB</u> – project ended a couple years ago – struggling with Sim funding – funded 'at risk', battling with senior management to gain funding for simulation activity. | |
| <u>DT-J</u> - Job planning is an issue. Consultants' engagement with Simulation as an item of job planning is crucial – senior registrars are taking reins currently as simulation but simulation work is not protected as a part of consultant job plan. | |
